For each draw, the organiser first determines who is eligible to be entered based on cheques received and standing orders paid in to the 100 Club bank account. (Adjudicated by Club Treasurer).

The draw will be undertaken at either a full Committee meeting of the Hockey Club, AGM, or on a Saturday evening at the Club House, as long as the Organiser, the Treasurer, and one other Committee member is present.
